



## 2007 ADULT CO-REC KICKBALL REGISTRATION FORM

Registration for **teams only** is now underway. Space is limited to eight teams per night. The entry fee is \$170 for resident teams (all Hopkins, Minnetonka, and Eden Prairie players), or \$195 for non-resident teams. The entry fee includes a game ball.

The season consists of seven weeks of play and a playoff. Separate Monday and Thursday night leagues are offered with games starting the week of June 4, 2007. The week of July 4 will be reserved for makeup games.

Games play at Central Park, Oberlin Park and Burnes Park in starting after 6:00 p.m. Games times are rotated throughout the season. A location map will be included with the game schedules.
