



**2009 ADULT CO-REC KICKBALL TEAM REGISTRATION FORM**

Team registration is now underway and space is limited to eight teams per night. Team entry fee is \$200 for resident teams (all players either live or work full-time in Hopkins, Minnetonka, or Eden Prairie); \$225 for non-resident teams. The entry fee includes one game ball for each team.

The season consists of seven weeks of play and a combined night playoff. Separate Monday and Thursday night leagues are offered with games starting the week of May 25, 2009. The May 25 game will be played on June 29. The week of June 30 will be reserved for makeup games.

Games are played at Central Park and Burnes Park in Hopkins, and at Gro-Tonka Park and Oberlin Park in Minnetonka. Games to be played at begin after 6:10 or 7:15 p.m. with starting times are rotated throughout the season. A location map will be included with the game schedules.

Phone registration is accepted by using a credit card. (Visa or MasterCard only) Call (952) 939-8203, Monday - Friday between the hours of 8:00 a.m. - 4:30 p.m. Remember, last year all leagues did fill to capacity.
